Phone Scammers in Athens

The Athens Police Department has issued a warning to the public about a scam involving a male caller claiming to be an Athens police officer. The caller demands a large amount of money to avoid going to jail, with the caller sometimes having personal information such as your name or address. Residents are advised to hang up, contact the Athens Police Department to verify the call's authenticity, and not provide any information over the phone. TWU Announces Athletic Restructuring



Tennessee Wesleyan University Athletics recently announced restructuring in their athletic department, with Coaches Jeff Rice and Ray Stone transitioning to new roles. Jeff Rice, a 1994 Tennessee Wesleyan graduate, will become Director of Golf while remaining head men's golf coach. Ray Stone, a TWU graduate from 2000, will shift to Assistant Athletic Director for Inter-

nal Operations after coaching men's basketball. Both coaches have long histories with the university and significant coaching experience. Their institutional knowledge and dedication will contribute to advancing Bulldog Athletics. Tennessee Wesleyan, a member of the NAIA, fields 19 teams in the Appalachian Athletic Conference. Donny Mayfield, TWU's Vice President and Director of Athletics, expresses gratitude for the coaches' contributions and emphasizes the university's commitment to investing in athletic programs. He stated, "the athletics programs at Tennessee Wesleyan continue to compete at a very high level. To maintain a competitive advantage, we must invest in our programs. Currently we have almost 400 student athletes competing around the nation. I am appreciative of the resources to build on the successes of Jeff and Ray, and the many coaches that came before them, and continue to work with them intheir new roles."
