Two Men Drown in Meigs County, Bodies Recovered Saturday Morning

Meigs County Emergency Services initiated recovery operations near the Blythe Ferry boat ramp over the weekend following the tragic drowning of two Cleveland men on Friday night. Tony Finnell, Director for Meigs County Emergency Services, described the water conditions as choppy and murky due to debris from recent storms, with elevated water levels. The incident occurred when two young men, aged 19 and 20, accompanied by one of their girlfriends, went to a raised area near the Highway 60 bridge to swim. An eyewitness reported that one of the young men encountered immediate trouble after jumping into the water. The other attempted to rescue his friend but became trapped in the rough waters as well, leading to both of their drownings. Meigs and Rhea County Emergency services, along with Hamilton County crews, collaborated in the recovery efforts. Due to debris and rough winds, rescue operations were temporarily halted until Saturday morning. By deploying underwater sonar and a robot, crews recovered the first victim around 10:30 am on Saturday, followed by the second victim approximately two hours later. The two men were identified as Tristan Smith, 19, and J.C. Burrow, 20, both from Cleveland.

Courts Find Warrantless TWRA Searches Unconstitutional

The Tennessee Court of Appeals has ruled that state game wardens must obtain a warrant before entering private property in the state. This ruling limits a longstanding power held by the Tennessee Wildlife Resources Agency (TWRA) to conduct covert surveillance and patrols on privately-owned lands without judicial approval. TWRA officers have historically operated without the need for warrants, supervisor authorization, or documentation of their searches. They, at times, employ tactics such as wearing camouflage or installing hidden cameras to monitor activities based solely on individual officers' suspicions. The court's unanimous opinion likened TWRA's methods to the arbitrary searches conducted by British customs officials prior to the Revolutionary War, prompting comparisons to the protections in the U.S. Constitution's 4th Amendment. An attorney for Hunter Hollingsworth and Terry Rainwaters, two Benton County men who challenged TWRA's warrantless searches of their separate properties, called the decision “a massive win for property rights in Tennessee.” Emily Buck, the TWRA spokesperson, noted that the agency “voluntarily implemented a landowner consent process to enter private property and officers have already received additional training on obtaining search warrants when appropriate.” TWRA has the option to appeal the decision to the Tennessee Supreme Court within 60 days.
