Plot at MCHS Foiled by Parent

Two male juveniles face charges after a possible planned attack on other McMinn High School students was discovered Thursday night. According to Sheriff Joe Guy, a phone call he received from a parent of one of the juveniles around 1030pm Thursday, discovered something disturbing. "The parent was very concerned over a video recording he had discovered on a device belonging to his son," said Sheriff Guy. "The recording was made in November by his son and another student, dressed in masks and making statements that implied their planning of a school-shooting type attack, and naming certain students as possible targets. The parent felt it was his duty to report it as soon as possible." "Although the video had been made almost three months ago, statements were made regarding a planned attack with firearms, so of course we felt that the situation demanded quick attention. I immediately notified School Safety Supervisor Justin Wallace, McMinn High School SRO Sgt Jeremy Moore, and our local Homeland Security Agent." Sheriff Guy said that within an hour, School Safety Supervisor Wallace had spoken with the suspects' parents and arranged for the student suspects to be suspended from school beginning on Friday and scheduled them to undergo threat assessments and evaluations. Mr. Wallace, along with School Resource Officers and a Homeland Security Agent, worked throughout the day Friday to review the video, interview both suspects, began the investigation and collected evidence. Additional statements and evidence were located on the student's phones and prosecutors from the District Attorney General's Office were consulted regarding criminal charges. Both juveniles are charged with Conspiracy to Commit Acts of Terrorism, and are undergoing psychological evaluations and counseling. One is already in custody at the Bradley County Juvenile Detention Center, and the other is completing some treatment in a mental health facility and will be transferred to the Juvenile Center upon release. Their phones and devices have been sent for digital forensic evaluation to see if there is more information that's related to the planning of the incident. Both sets of parents are cooperating in the investigation. The investigation has not revealed any other suspects involved in the incident. Sheriff Joe Guy said trust, communication, and working together were all key in the successful intervention. ⇨

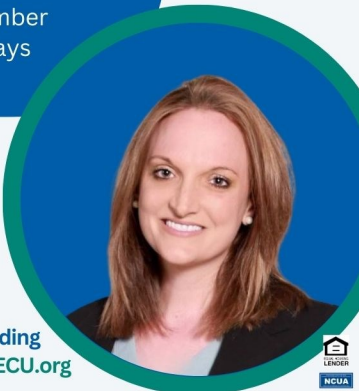

Storm Kills at least two in East TN



A tornado struck Morgan County, Tennessee, on Thursday night, killing a mother and daughter in the Deer Lodge and Sunbright areas. Emergency crews are assessing the damage and clearing roads,

while Wartburg Central High School has been opened as a shelter.

The storm system triggered tornado warnings across East Tennessee, briefly disrupting events like a high school basketball game and a Lady Vols basketball game in Knoxville.

An EF-1 tornado with 110 mph winds was confirmed in Grainger County, causing damage in Bean Station and Thorn Hill. In Fountain City, a tree fell on a church, but no injuries were reported. Crews are working to restore power and clear debris as officials urge residents to stay cautious.

Tennessee Dominates Oklahoma in 70-52 Victory

Tennessee dominated Oklahoma 70-52 on Saturday, using a scorching first-half shooting performance to build a commanding lead. The Vols (20-4, 7-4 SEC) hit 15 of their first 17 shots, including 5-of-5 from beyond the arc, and led by as many as 28 points. Chaz Lanier led Tennessee with 21 points, while Zakai Zeigler added 17 points and nine assists. The Vols went into halftime with a commanding 45-25 lead. Despite a brief push from Oklahoma (16-7, 3-7 SEC), cutting the gap to 49-34 early in the second half, Tennessee maintained control. Oklahoma was held to just 32.1% shooting, while the Vols finished at 60.4%. The Volunteers play their second consecutive road game Tuesday at 7 p.m. at No. 14 Kentucky, live on ESPN from Rupp Arena in Lexington, Ky. *Source: UTSports.com*

Nuwer Makes History in Tennessee Debut; Mardjetko Shines in First Start



Freshman pitcher [Erin Nuwer](#) (Top) and sophomore pitcher [Sage Mardjetko](#) (Bottom) delivered dominant performances in their first starts as Lady Vols Friday at the NFCA Leadoff Classic, leading Tennessee to a pair of run-rule victories over Bethune-Cookman and Iowa. Nuwer, making her first career start, fired a five-inning no-hitter against Bethune-Cookman in a 10-0 win. Nuwer joined legendary pitcher Monica Abbott as the only Lady Vols to throw a no-hitter in their Tennessee debut. The right-hander struck out eight and allowed only one walk, coming in the third inning. Her no-hitter marked the 59th in Tennessee history. Mardjetko, in her first start as a Lady Vol, was equally impressive in game two against Iowa. After giving

up an early run in the second inning, she escaped a bases-loaded jam and went on to dominate the Hawkeyes lineup. Mardjetko surrendered just two hits, walked one, and recorded a career-high 11 strikeouts.

Lady Vols Upset No. 5 UConn in Thrilling 80-76 Victory



The **No. 19/17 Tennessee Lady Vols** secured a **major upset** over **No. 5 UConn** on **Thursday night**, defeating the Huskies **80-76** in front of a raucous **16,215 fans** at **Food City Center**. The victory snapped a **four-game losing streak** against UConn and marked Tennessee's **first win over the Huskies since 2007**.

Zee Spearman led the Lady Vols with **16 points**, including a crucial layup with **12 seconds left** to seal the win. **Samara Spencer** contributed **14 points**, while **Jewel Spear** and **Talaysia Cooper** added **12 and 11 points**, respectively. Cooper also led the rebounding effort with **eight boards**, as Tennessee out-rebounded UConn **46-34**.

The **back-and-forth battle** saw Tennessee build a **nine-point lead** in the third quarter before UConn rallied to tie the game at **74-74** with just over **two minutes remaining**. However, Tennessee held strong, using **clutch free throws** and key defensive stops to hold on for the victory.

The win is head coach **Kim Caldwell's biggest at the Division I level** and gives the Lady Vols their **second ranked win this season**, following their victory over **No. 17/20 Iowa** in December.
