

- The Niota Planning Commission will have its regular scheduled meeting on February 20th 10am, in the Niota City Hall, 9 West Willson St.
- The UT Extension McMinn County is hosting the Matter of Balance workshop which will take place from March 4 to March 27. It will meet on Tuesdays and Thursdays from 10:00 AM to 12:00 PM at First Baptist Church (Fellowship Hall), located at 305 Ingleside Ave., Athens. This workshop is designed to help older adults manage their fear of falling and stay active. Participants will learn strategies to reduce fall risks, set realistic activity goals, and practice simple exercises to improve strength and balance. The program aims to promote independence and enhance quality of life by preventing the physical and emotional effects of falling-related fears. Class instructors Sarah Kite and Kathleen Reid will lead the sessions, and all participants will receive a Matter of Balance workbook and other materials. The class is free, but limited to 12 participants, and registration is required by calling 423-745-2852.

Weekend weather creates AUB outages



Over the weekend of February 15-16, 2025, the Athens Utilities Board (AUB) service area experienced significant power outages due to high winds and fallen trees. The severe weather conditions led to multiple incidents affecting various parts of the region:

- West Athens: A downed primary neutral line near Trio Equipment resulted in power loss for 293 accounts.
- Southern Parkway: A large pine limb fell on a three-phase line, disrupting service to 46 accounts.
- Niota: A tree caused extensive damage by taking down power lines and a pole, with the transformer landing on a house. This incident affected 91 customers.
- Englewood Area: Multiple outages across the area with some residents experiencing flickering power due to a tree limb impacting the lines.
- Additional Outages: Numerous smaller and individual outages were reported across the entire service area.

AUB crews worked diligently throughout the weekend to address these issues, prioritizing safety and efficient restoration of services. Customers are encouraged to report outages promptly to 423-745-3131 to assist in the restoration efforts. For future updates and information, AUB recommends following their Facebook page especially during storms.

The sixth-ranked Lady Vols capped off a perfect weekend with a 5-0 victory over Nicholls on Sunday at the LU Softball Complex in Beaumont, Texas. Tennessee (10-1) went undefeated, securing five wins, including two against McNeese and additional victories over Lamar, Tulsa, and Nicholls, extending their winning

streak to 10 games.

Sophomore pitcher Sage Mardjetko delivered a dominant performance, throwing a one-hit complete-game shutout with a career-high 13 strikeouts. She allowed just one walk and carried a no-hitter into the fifth inning, earning her fourth win of the season. Over the weekend, Mardjetko collected two wins, allowing only two hits in 12 innings while striking out 17 batters. Key contributions also came from Laura Mealer, Bella Faw, and Sophia Nugent, helping the Lady Vols secure their final victory of the weekend.

Tennessee now turns its attention to the Mary Nutter Collegiate Classic in Cathedral City, California, from Feb. 20-22, where they will face Oregon State, No. 21 Oregon, Rutgers, No. 4 UCLA, and Minnesota.
