Two-Vehicle Crash on Highway 68 Sends One to Hospital

A two-vehicle crash Tuesday evening just after 5:00 p.m. on Highway 68 near County Road 286 left one person hospitalized, authorities said.

According to officials, a 2009 BMW traveling north and a 2007 Lincoln heading south collided nearly head-on. Each vehicle had a single occupant. The driver of the Lincoln sustained minor injuries, while the BMW driver was transported to a local hospital after being extricated by firefighters.

Responding to the scene were the North McMinn and Niota Fire Departments, the McMinn County Sheriff's Department, AMR, and the Tennessee Highway Patrol (THP). Assistant Fire Chief Cody Millsaps served as incident command, and Trooper Caleb Ballard is leading the investigation.
