Lenoir City Man Charged in Crash That Killed Blount County Deputy



A Lenoir City man has been charged in connection with the crash that claimed the life of Blount County Sheriff's Deputy Justin Mowery, according to the Blount County Sheriff's Office.

Authorities said 24-year-old Dalton Michael Bowman faces multiple charges, including evading arrest resulting in the death of a law enforcement officer, a Class A felony. He is also charged with possession of a weapon by a convicted felon, driving on a suspended license, driving without a license, and simple possession of methamphetamine.

Bowman, a convicted felon, was arrested Monday afternoon on a Loudon County warrant and is currently being held without bond at the Loudon County Correctional Facility. Officials said he will later be transported to Blount County for arraignment.

Investigators with the Blount County Sheriff's Office worked alongside the Loudon County Sheriff's Office and the Tennessee Highway Patrol to identify Bowman as the suspect. During his arrest, authorities said Bowman was found in possession of a handgun and approximately six grams of methamphetamine.

Officials also confirmed the motorcycle Bowman was riding at the time of Deputy Mowery's death had been reported stolen out of Loudon County. According to the sheriff's office, Bowman later admitted he knew Deputy Mowery was attempting to stop him when he fled.

The investigation remains ongoing, and additional charges may be filed.

Athens Planning Commission to Meet Today at Noon



The Athens Municipal-Regional Planning Commission will meet Monday, Jan. 5, at noon in the conference room.

The agenda includes approval of minutes from the Dec. 29, 2025 work session and the Dec. 1, 2025 regular meeting.

Under new business, the commission will hear public comments and consider final plat approval for Porter Clark on property located off Decatur Pike and the unopened Railroad Avenue right of way. The request involves three lots totaling 0.61 acres, zoned B-3 Intensive Business District and R-2 Medium Density Residential.

Commission members will also review and make a recommendation regarding the potential addition of microbreweries and distilleries as permitted uses in the B-2 Central Business District and B-3 Intensive Business District.

Time will be allotted for petitions and requests from the audience, followed by a staff report.




