## McMinn County Deputy to Receive Commendation for Bravery



A McMinn County deputy will be recognized for extraordinary bravery following his actions at a fatal crash on Highway 68 involving a stolen vehicle pursued by Sweetwater Police. Sheriff Joe Guy said Deputy Kelby Liner's response, documented through witness statements and body camera footage, clearly went beyond the call of duty.

Deputy Liner was approaching the area when he was advised the suspect vehicle had crashed head-on into another car. Upon arriving to find both vehicles on fire, Liner immediately deployed a pressurized water can he personally purchased, provided a fire extinguisher to a Sweetwater officer,

and began fighting the blaze. A trained volunteer firefighter, Liner also directed other responders and later took a hose from a responding fire truck to continue extinguishing the fire, exposing himself to danger from flames and debris.

Once the fire was reduced, Liner helped open the passenger door of one vehicle and assisted in removing a victim so life-saving efforts could be attempted. He continued battling the fire and aiding other responders despite the extreme conditions. Sheriff Guy said that although two victims and the suspect were ultimately killed, Liner's actions were described by witnesses as heroic and gave victims the best possible chance. Liner will receive a formal commendation, and the sheriff's office offered prayers to the families affected by the tragedy.

## Songwriter's Night to Close Black Box Concert Series at The Arts Center

The Athens Area Council for the Arts will close its 2025–2026 Black Box Concert Series with *Songwriter's Night with Kyshona* on Friday, Feb. 6, at 7 p.m. in the Sue E. Trotter Black Box Theater at The Arts Center.

The intimate concert will feature Kyshona Armstrong alongside fellow singer-songwriters Damien Horne and Joy Clark. Curated by Armstrong, the evening will showcase original music and storytelling from the three artists.

Armstrong, a singer-songwriter and licensed music therapist, is known for music centered on community, healing, and untold stories. Joining her is Joy Clark, a Louisiana native whose debut album *Tell It to the Wind* reflects both personal independence and deep-rooted musical traditions. Also performing is Damien Horne, a North Carolina native who later moved to Nashville, where his career included national touring after being discovered by country artist John Rich.

Tickets for the performance are on sale now and range from \$20 to \$25. All Black Box Concert Series events are held in the Sue E. Trotter Black Box Theater, and patrons are encouraged to purchase tickets in advance.

## Driver Flees Scene After Crash in Englewood



Authorities are searching for the driver of a 1998 Ford Explorer who fled the scene of a crash Thursday night around 9 p.m. at the intersection of North Niota Road and Harlan Daugherty Street.

Emergency responders arrived to find the vehicle involved in a single-vehicle accident, but the driver had already left the area. Etowah City Fire's K-9 unit, Remi, and handler Firefighter Austin Hancock were deployed to search for the driver, but the individual was not located.

Responding agencies included the Englewood Police Department, McMinn County Sheriff's Department, Englewood Rural Fire Department and AMR. The Tennessee Highway Patrol is investigating the crash, with Trooper Casey Shell assigned to the case.
